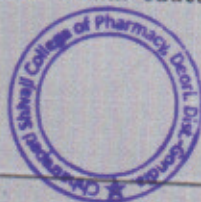




### 3. DURATION OF MoU :
