1. Objectives of the MoU

2. Areas of Collaboration

- Collaboratively provide services to general public, school children, and special groups.
- The Vishwa Sindhi Seva Sangam will provide travel allowance, venue and basic arrangements for the staying of oral health care team as well as all the arrangements needed to conduct camps and programs.**
- The Chhattisgarh Dental College & Research Institute will provide oral health care team, instruments, materials, medicines to conduct camps and programs.

3. Duration of MoU

This MoU shall be valid for the period of 2 (Two) years commencing from the date of MoU, unless terminated in writing by any of the parties by serving 30 day's notice thereof the term may be extended for further period by mutual consent in writing by the parties.
